

RESOLUTION NUMBER R- 266660

ADOPTED ON SEP 23 1986

WHEREAS, it is the policy of the Council of The City of San Diego, upon recommendation of the Planning Commission, to authorize community planning and development programs and the commitment of the City Manager and Planning Department personnel necessary to provide comprehensive planning services; and

WHEREAS, the Midway Community Planning Advisory Committee is established as a formal organization which is capable of providing proper coordination and communications with City staff forces; and

WHEREAS, the Midway Community Planning Advisory Committee has submitted bylaws, operating rules and procedures as required by Council Policy No. 600-24, a copy of which has been filed in the office of the City Clerk as Document No. RR- 266660-1; and

WHEREAS, it is the opinion of the City Council that the Midway Community Planning Advisory Committee, composed of a cross-section of the civic, social, resident, business, professional and industrial representation within the Midway area of The City of San Diego, satisfies the criteria set forth in Council Policy No. 600-5 and No. 600-24, policies of The City of San Diego with respect to community plans; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the Midway Community Planning Advisory Committee be, and it is hereby authorized to represent the Midway community, consisting

of the area included within the map attached hereto as Exhibit "A," a copy of which is on file in the office of the City Clerk as Document No. RR- 266660-2. This action deletes the portions of the Midway Plan which were included in the City's Local Coastal Program application in 1981. Those portions of the Midway Plan affected by this deletion will be placed into an appropriate community planning area at the time a decision is made on the boundaries of the Peninsula Community Planning area.

BE IT FURTHER RESOLVED that the City Manager's office and the Planning Department are directed to work with the advisory committee in the development of a long-range community plan consistent with community goals and objectives and be responsible for its presentation as well as the coordination of community support for its adoption and effectuation.

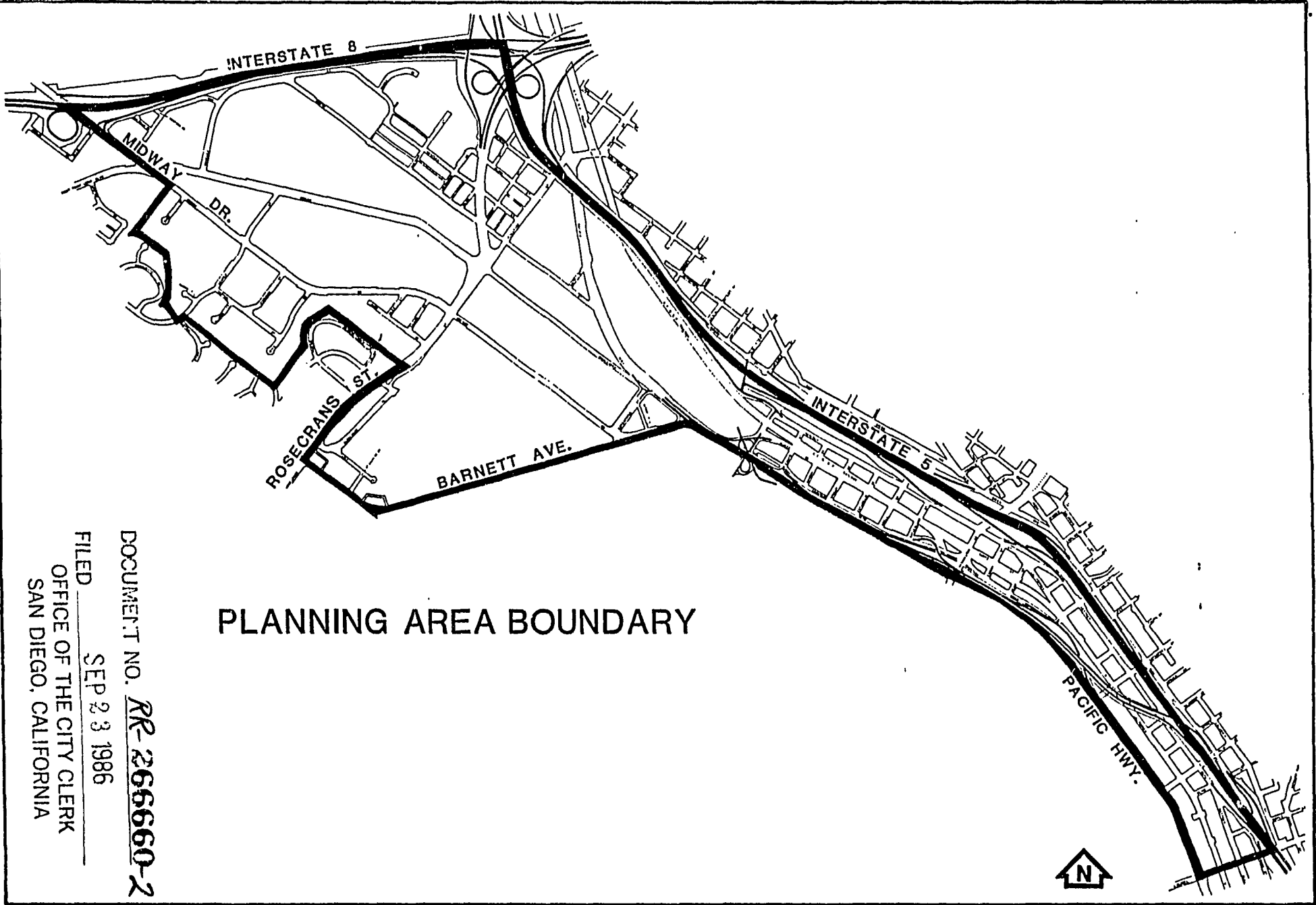
