WHEREAS, a local board of representatives of the local units of the agencies listed above, plus representatives of the Emergency Resources Group (ERG), the San Diego-Imperial Counties Labor Council, Neighborhood House Association, and the cities of Chula Vista, El Cajon, Escondido, La Mesa, National City, Oceanside, and the City and County of San Diego have overseen the expenditure of the funds allocated to the San Diego area; and

WHEREAS, the local board agreed that it would utilize the ERG, a multi-agency coalition involved in providing all types of emergency assistance, to develop and implement a plan for the expenditure of the federal funds; and

WHEREAS, in a very short period of time, ERG was able to develop county-wide programs for rent and mortgage assistance, congregate feeding, meal vouchering, shelter vouchering, and congregate shelter; and
