

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That the bid of \$50,156 by P & P ENTERPRISES Inc., a corporation, for TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the specifications on file in the Office of the City Clerk as Document No. 118409.
- 2. That the City Auditor and Comptroller is hereby authorized to transfer \$10,000 from PSD Fund 11340 to CIP No. 23-590.4, TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS.
- 3. That the expenditure of \$10,000 from CIP No. 23-590.4, TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS to supplement funds previously authorized by Resolution No. 259160, adopted on September 12, 1983 and Resolution No. 264948 adopted on February 3, 1986 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
