WHEREAS, the Seventh Annual 13K Coronado Bridge Run and Walk for Leukemia is to be held on Sunday, October 12, 1986; and


WHEREAS, the race is to start in the City of Coronado and proceed over the San Diego-Coronado Bay Bridge finishing in Balboa Park; and
