WHEREAS, the International Affairs Board is established pursuant to the San Diego Municipal Code section 26.22 et seq.; and

WHEREAS, section 26.23 vests in the Board the authority to foster and promote friendly relations and better understanding between people's of and communities of the United States and the people and communities of foreign nations; and

WHEREAS, one of the methods used in promoting such mutual understanding and goodwill is the formation of Sister City relationships; and

WHEREAS, the Board undertakes such official Sister City affiliation with the consent of the Mayor, Council and the Sister Cities International; and

WHEREAS, the Board considered the matter of pursuing and establishing a Sister City relationship with the City of Perth, Australia and unanimously approved such action; and

WHEREAS, it is now recommended to the City Council that such action to establish said affiliation be approved; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation of the International Affairs board, as reflected in the letter dated September 10, 1985 to actively pursue and establish, for and on behalf of the people of The City

of San Diego, a Sister City relationship with the City of Perth,  
Australia, be and the same is hereby approved.
