WHEREAS, the Department of the Navy intends to redevelop the Broadway Complex, an eight city block site bounded by Broadway, Pacific Highway, Martin Luther King, Jr. Way and Harbor Drive; and

WHEREAS, the Navy's program for redevelopment of this site includes office space for 5,000 employees, occupying over one million square feet of space and parking for 2,000 vehicles in addition to other on-site amenities; and

WHEREAS, the Broadway Complex Coordinating Group, under the administration of the San Diego Association of Governments (SANDAG) has been working with the Navy in resolving potential local issues; and

WHEREAS, this Coordinating Group has determined that the development of this site could have major impacts on the rest of the downtown market; and

WHEREAS, the Coordinating Group has decided to retain the assistance of a consultant to assess the impact of the development; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego will contribute monies for consultant services matching like funds being contributed by the Unified Port District, Centre City Development Corporation, the Department of the Navy and the County of San Diego.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, a joint participation agreement with SANDAG for the hiring of a consultant, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR- $\frac{266684}{1}$ .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$15,000 from the Planning Department budget (Miscellaneous Contractual Services) is hereby authorized solely and exclusively for the purpose of providing funds for the above project.
