RESOLUTION NUMBER R- 266685

ADOPTED ON SEP 29 1986

WHEREAS, Proposition 61 on the November 4, 1986 statewide ballot (commonly called "Gann" initiative) would adversely impact salary and compensation of all public employees; and

WHEREAS, said initiative would negatively affect the home rule powers of charter cities such as San Diego; and

WHEREAS, if passed, it would have a serious negative impact on City government and other public agencies by virtue of the anticipated prospective loss of senior experienced personnel; and

WHEREAS, the total impact is contained in City Manager's Report No. 86-422, dated September 9, 1986, said report recommending opposition to Proposition 61; and

WHEREAS, the Rules Committee considered said recommendation at its September 15, 1986 meeting and unanimously approved the opposition to said Proposition; and


WHEREAS, the matter is now forwarded to the full Council for appropriate action; NOW, THEREFORE,
