

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$187,000 from Mid-City Park Dev. Fund 39094; CIP 29-584.0, Adams School/Park - Acquisition, to cover the opportunity acquisition of this 7,000-sq.ft. lot and related costs for the proposed Adams School/Park expansion, be and the same is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk shall deliver the deed and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
