

RESOLUTION NUMBER R- 266696

ADOPTED ON SEP 30 1986

A RESOLUTION AMENDING THE PENASQUITOS EAST COMMUNITY PLAN AND THE PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO.

WHEREAS, the PENASQUITOS EAST COMMUNITY PLAN was adopted by the City Council on October 17, 1978, under Resolution No. 222051; and

WHEREAS, an Addendum to that plan was approved by the Planning Commission on January 15, 1981, under Resolution No. 2979; and

WHEREAS, the Carmel Rancho Project (Unit 1) was approved by the City Council for rezoning to R1-5000 under Ordinance No. 15611 (New Series), adopted November 11, 1981; and

WHEREAS, the Black Mountain Glen Project was approved by the City Council for rezoning to R1-5000 under Ordinance No. 15815 (New Series), adopted September 13, 1982; and


WHEREAS, it is desirable that the above-referenced Addendum and development projects be formally incorporated into the PENASQUITOS EAST COMMUNITY PLAN to clearly delineate the extent of urban development contemplated by that plan; and

WHEREAS, an amendment to the PROGRESS GUIDE AND GENERAL PLAN is also required to ensure that the areas shown as planned for urban development on the General Plan Map and the Phased Development Areas Map are coterminous with the PENASQUITOS EAST COMMUNITY PLAN as herein proposed to be amended; and

WHEREAS, the Planning Commission held a noticed public hearing and, under Resolution No. 6391, adopted June 19, 1986, approved and recommended that the City Council adopt the proposed amendments to the PENASQUITOS EAST COMMUNITY PLAN and the PROGRESS GUIDE AND GENERAL PLAN; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said amendments to the PENASQUITOS EAST COMMUNITY PLAN and the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO be, and the same are hereby adopted.
