


RESOLUTION No. R- 266707 (R-87-434)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of EUGENE CARTER ENTERPRISES INC. dba ENVIRON. MAINT. SER. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing JANITORIAL SERVICES FOR THE SOUTHERN, NORTHERN, NORTHEASTERN, AND EASTERN POLICE SUBSTATIONS as may be required for a period of one (1) year beginning November 1, 1986 through October 31, 1987, for a cost of \$61,484.64 plus \$12.00 per hour for extra service; terms 2.5% 20 days, with options to renew contract for three (3) additional one (1) year periods, with escalation not to exceed 8% for the first option period and not to exceed 7% each year for the last two (2) option periods.
