

That the expenditure, not to exceed \$380,000 from Special Litigation Reserve Fund 65011, CIP No. 37-317 SDG&E Street Lights Acquisition and Conversion is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, to retain excess budgeted funds, if any, in Special Litigation Reserve Fund

65011, CIP No. 37-317 SDG&E Street Lights Acquisition and
