1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CRYSTAL PIER - RECONSTRUCTION, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on OCT 06 1986 and bearing official Document No. W.O. 118807 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CRYSTAL PIER - RECONSTRUCTION.
4. That the expenditure, not to exceed \$458,383 from Revenue Sharing Fund 18014, CIP No. 37-137 CRYSTAL PIER - RENOVATION, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
