RESOLUTION NUMBER R- 266717

ADOPTED ON OCT 06 1986

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where a street has been superseded by relocation; and

WHEREAS, the abutting property owner has requested the vacation of Palm Avenue in a portion of the southeast quarter of the southwest quarter of Section 22 Township 18 south Row 2 west, S.B.M., to facilitate development of the property; and

WHEREAS, the property adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Palm Avenue in a portion of the southeast quarter of the southwest quarter of Section 22 Township 18 south Row 2 west, S.B.M., as more particularly shown on Drawing No. 16565-B on file in the office of the City Clerk as Document No.

RR- 266717-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

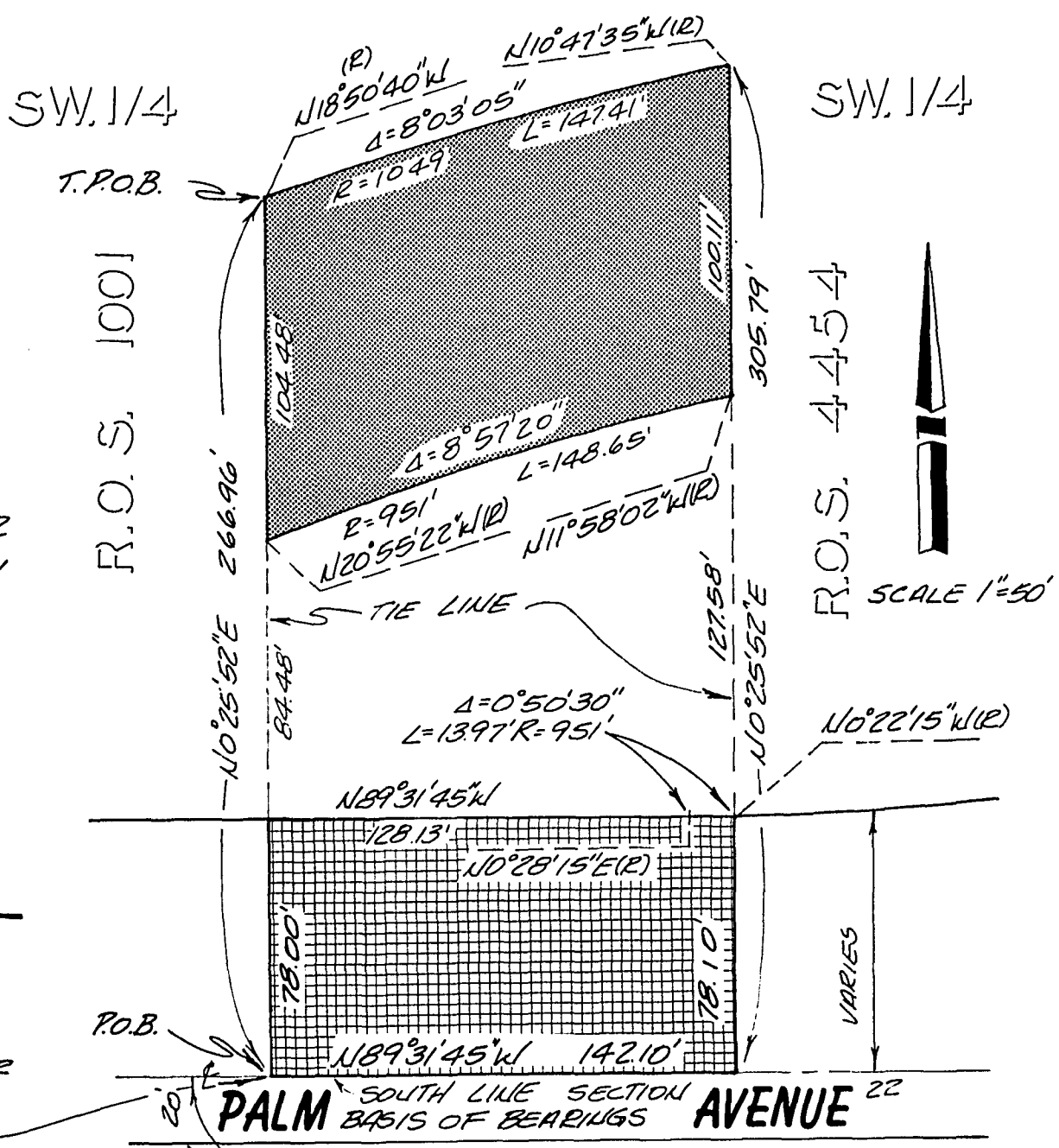
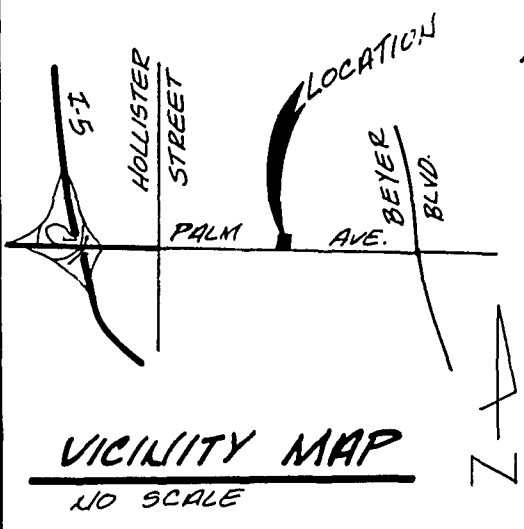


BASIS OF BEARINGS


