- 1. Mr. Murray is hereby placed on official terminal leave from 2 PM, October 13, 1986 until 5:00 PM, January 15, 1987 and paid in accordance with his present salary scale including all other present and usual terminal leave benefits to be paid by biweekly checks (with his present automobile and expense allowance to be discontinued commencing at 2 PM, October 13, 1986).
- 2. On January 30, 1987, City will pay Mr. Murray the usual and normal employee termination payments such as Supplemental Pension Savings Plan, leave and accrued benefits earned. Leave accrued as of the date of resignation will not be reduced during terminal leave and will be paid with this final payment.
- 3. On January 30, 1987 Mr. Murray will be paid a severance amount to be computed as follows:
 - A. An amount equal to 13 pay periods biweekly present salary; plus
 - B. An amount equal to 13 pay periods ICMA present deferred compensation - (paid directly to ICMA); plus
 - C. An amount equal to 13 pay periods of Management Benefits Plan and Flexible Benefits Plan premiums for any existing insurance coverage to be paid directly to the appropriate insurance carrier on Mr. Murray's account.
 - D. An amount equal to 13 pay periods of any Management

 Benefits Plan or Flexible Benefits Plan allocations not

paid to or utilized by Mr. Murray by January 15, 1987 for cash benefit or Dental/Vision reimbursements.

E. An amount equal to 40% of 13 pay periods of the City's present matching contribution to his Supplemental Pension Savings Plan, plus 20% of the accumulated City's matching contribution as of January 15, 1987.

To the extent provided by law any and all benefits set forth herein may be payable to Mr. Murray's heirs and assigns; and shall be payable in all events whether Mr. Murray obtains other employment prior to January 30, 1987; and to the extent allowed by law shall be paid to Mr. Murray irrespective of the passage of Proposition 61 in the November 4, 1986, election.
