That the bid of JACKSON & BLANC is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing FULL MAINTENANCE SERVICE ON THE HEATING, VENTILATING, AIR CONDITIONING, TEMPERATURE CONTROL SYSTEM & OTHER MECHANICAL EQUIPMENT AT SAN DIEGO JACK MURPHY STADIUM, Base bid including equipment in Appendix A, as may be required for a period of one (1) year beginning November 1, 1986 through October 31, 1987 for a cost of \$5,486.00 per month, for a total cost of \$65,832.00; terms net, with an option to renew contract for four (4) additional one (1) year periods.
