APPROVING MAP OF CARMEL VALLEY
NEIGHBORHOOD 1 - UNIT 2.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Phillip S. Butcher, Licensed Land Surveyor, entitled "CARMEL VALLEY NEIGHBORHOOD 1 - UNIT 2 being a subdivision of portions of Parcels 1 and 2 of Parcel Map No. 11102, as filed in the office of the County Recorder of San Diego County, March 13, 1981 as File No. 81-077513 of official records, and a portion of Parcel 3 of Parcel Map No. 11045, as filed in the office of County Recorder of San Diego County, February 27, 1981 as File No. 81-060790 of official records, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Carmel Center Road, Futura Street, Lupita Court and Mistral Place, and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Carmel County Road, adjacent and contiguous to Lots 18 through 32, inclusive, and Lot 80; in and to Lupita Court, adjacent and contiguous to Lots 35 and 36, and in and to Carmel Center Road, adjacent and contiguous to Lots 65 through 70, inclusive, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) listed in paragraphs 2 through 4 of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, that said street(s) are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easement(s) listed in paragraphs 2 through 4 of the Owner's Certificate, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.

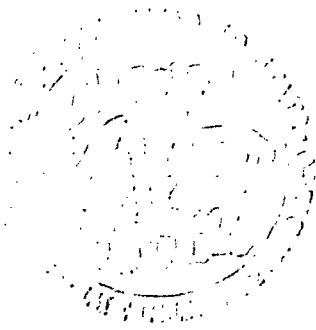
