
RESOLUTION NUMBER R- 266768

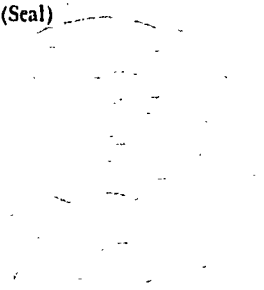
