APPROVING MAP OF CARMEL VALLEY
NEIGHBORHOOD 1 - UNIT 14.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Phillip S. Butcher, Licensed Land Surveyor, entitled "CARMEL VALLEY NEIGHBORHOOD 1 - UNIT 14 being a subdivision of portions of Parcels 1, 2 and 3 of Parcel Map No. 11102, as filed in the office of the County Recorder of San Diego County, March 13, 1981 as File/Page No. 81-077513 of official records, and a portion of Parcel 3 of Parcel Map No. 11045, as filed in the office of the County Recorder of San Diego County, February 27, 1981 as File No. 81-060790 of official records, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Carmel Center Road, Cortesal Fresco and Corte de la Fonda, and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for


the construction and maintenance of sewer, drainage and general utility facilities as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) are accepted on behalf of the public as heretofore stated; that together with the easement(s) with the right of ingress and egress for the construction and maintenance of drainage, sewer and general utility facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
