APPROVING MAP OF EUCLID GARDENS.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Jerome M. Pinney, Registered Civil Engineer, entitled "EUCLID GARDENS being a subdivision of a portion of Lot 15, Wadsworth's Olive Grove, in the City of san Diego, County of San Diego, State of California, according to map thereof No. 482, filed in the office of the County Recorder of said San Diego County, February 10, 1888," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Euclid Avenue, and said portion of street is hereby declared to be a portion of public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the easements listed in paragraphs (1) and (2) of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon or across all those portions of Lot 1, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a street is accepted on behalf of the public as heretofore stated; together with the easements listed in paragraphs (1) and (2) of the Owner's Certificate, and the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
