WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where a street has been superseded by relocation; and

WHEREAS, the abutting property owners have requested the vacation of the portion of Dowdy Drive northwesterly of Miramar Road in conjunction with the Mira Este (T.M. 85-0645) subdivision to facilitate development of their properties; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the portion of Dowdy Drive northwesterly of Miramar Road in conjunction with the Mira Este (T.M. 85-0645) subdivision as more particularly shown on Drawing No. 16716-B on file in the office of the City Clerk as Document No. RR- 266784-/ which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the resolution shall not become effective unless and until the final subdivision map for Mira Este (T.M. 85-0645) has been approved by Council action. In the event that the final subdivision map is not approved by November 12, 1988, this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.


