WHEREAS, the City Council of The City of San Diego, by Resolution No. R-265036 adopted on February 10, 1986, has authorized and empowered the City Manager to establish Special Trust Fund 10132, Seized and Forfeited Assets, for deposit of the proceeds of all assets received by the City through the Federal Forfeiture Program pursuant to the Comprehensive Crime Control Act of 1984 and the guidelines promulgated thereto, and

WHEREAS, said funds may be expended for law enforcement purposes pursuant to the provisions of Resolution No. R-265036, and

WHEREAS, a need has arisen for training a narcotic detection dog handler, and

WHEREAS, no funds have previously been budgeted for said purpose, and

WHEREAS, the Alderhorst Kennels of Riverside, California has previously been identified by The City of San Diego as the only entity within a reasonable distance appropriately licensed and qualified for training and certifying narcotic detection dog handlers, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to expend
