

RESOLUTION NUMBER R- 266806

APPROVING MAP OF RESUBDIVISION OF FRIEDRICK
MANOR.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Emory P. Giblin, Registered Civil Engineer, entitled "RESUBDIVISION OF FRIEDRICK MANOR being a subdivision of Lots 1 to 11, inclusive, and Lots 13, 15, 18, 19, 20, and 21 of Friedrich Manor, in the City of San Diego, County of San Diego, State of California, according to the map thereof No. 9197, filed in the office of the County Recorder of San Diego County, April 30, 1979, also Parcels 1, 2, 3, and 4 of Parcel Map No. 10684, filed in the office of the County Recorder of San Diego County, November 7, 1980, together with Whaley Avenue, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys and that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Grape Street, Fir Street, Elm Street and Date Street, adjacent and contiguous to Lots 33 and 34, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of slopes, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across Lots 33 and 34, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; that those certain abutters' rights of access, together with the easement(s) with the right of ingress and egress for the construction and maintenance of slopes, and the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
