WHEREAS, the City Council has reviewed and considered the information and research materials considered by the Historical Site Board; and

WHEREAS, the City Council heard and considered public testimony and written correspondence on this matter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby upholds the decision of the Historical Site Board to designate the four buildings within the Green Dragon Colony as historically and architecturally significant structures (i.e., the Dolly Varden, East Cliff, Jack O'Lantern and Gables cottages at 1241 and 1243 Coast Boulevard and 1260 and 1268 Prospect Street, respectively).
