ADOPTED ON OCT 14 1986

WHEREAS, it is anticipated that a vacancy will exist in Council District 8 on or before November 13, 1986; and

WHEREAS, The Charter of The City of San Diego requires the City Council to fill such a vacancy within thirty (30) days of said vacancy by appointment or immediately cause a special election to be held to fill said vacancy; and

WHEREAS, the Council has considered whether to fill the expected vacancy by appointment; and

WHEREAS, the San Diego Municipal Code provides the detailed mechanisms for filling vacancies in elective office at San Diego Municipal Code section 27.3101 et seq.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby intends to fill the anticipated vacancy through the appointment process with the intention that said office will be filled by an individual who will serve the remainder of the term but will not run for election thereby encouraging a full and open election in the normal course with the regular election to fill the District 8 seat in 1987.
