Curry, etc., et al. v. John Steward, etc., et al., resulting from personal injuries to Andrew Curry and Scott Curry and wrongful deaths to Michael Curry and Ricki Curry.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$200,000.00, made payable to the SAN DIEGO COUNTY CLERK, towards settlement of the lawsuit and of all claims.

BE IT FURTHER RESOLVED, that said funds are to be payable from Fund No. 81140, Public Liability Reserve Fund.
