RESOLUTION NUMBER R- 266857

ADOPTED ON OCT 27 1986

WHEREAS, the San Diego Regional Center, affiliated with the State of California's Department of Developmental Disabilities Services, provides educational and rehabilitative services to developmentally disabled clients attending day programs at various agency sites within the City; and

WHEREAS, many of Regional Center's clients are City residents eligible to purchase a limited amount of Dial-A-Ride coupons at 75% or 85% discount, said discounts subsidized by Dial-A-Ride from a combination of State Transportation Development Act (TDA) and City funds; and

WHEREAS, Regional Center's program transportation is designed so that several of their clients travel in a single vehicle from various locations to a common destination on a daily basis and the delivery of service in this manner makes the use of coupons by the passenger a cumbersome method of payment; and

WHEREAS, a more effective method would entail a third party billing arrangement among the transportation provider, the City and Regional Center; and

WHEREAS, this agreement would allow the San Diego Regional Center to fund Dial-A-Ride service:

- (1) at 25 % of cost for their clients who are eligible for the City's monthly allocation for taxi trips,

(2) at 15% for clients who are eligible for the City's monthly allocation for wheelchair lift-equipped van service,

(3) at 100% of cost for service to their clients in excess of the City's monthly allocation, and

(4) at 100% of cost for service provided to their clients who are not eligible for the City's subsidy;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego Regional Center, for the purpose of selling Dial-A-Ride services to Regional Center's designated clients attending Day Programs, for the period October 1, 1986 through June 30, 1987, pursuant to the terms and conditions of the Purchase of Transportation Services agreement, on file in the office of the City Clerk as Document No. RR- 266857
