RESOLUTION NUMBER R- 266861

ADOPTED ON OCT 27 1986

WHEREAS, the Department of Fish and Game of the State of California has requested permission to place an artificial fishing reef off the entrance to Mission Bay, San Diego County, an area bounded by latitude 117°16'48" West, longitude 32°46'27" North by latitude 117°16'00" West, longitude 32°46'25" North by latitude 117°17'00" West, longitude 32°44'58" North, by 117°16'14" West, 32°44'50" North, to be more specifically defined by the Department of Fish and Game of the State of California, ranging from 60 to 100 feet deep, consisting of about 5,000 tons of viaduct demolition debris and a scrapped kelp harvester vessel together with the possible Naval Ocean Systems Oceanographic Platform; and

WHEREAS, the overall size is estimated to be 0.11 nautical miles wide by 0.65 nautical miles long, with plastic buoys of a type nonhazardous to small craft, and maintained at no expense to the City; and

WHEREAS, said artificial fishing reef is to be created in order to improve fishing and was initiated at the instance of the sports fishermen of San Diego County; and


WHEREAS, the City Manager recommends that the permission requested be granted subject to the approval of the United States Coast Guard and the United States Army Corps of Engineers; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That, subject to the prior approval of the United States Coast Guard and the United States Army Corps of Engineers, the Department of Fish and Game of the State of California is hereby granted permission to place an artificial fishing reef off the entrance to Mission Bay, San Diego County, an area bounded by latitude 117°16'48" West, longitude 32°46'27" North by latitude 117°16'00" West, longitude 32°46'25" North, by 117°17'00" West, 32°44'58" North by latitude 117°16'14" West, longitude 32°44'50" North, to be more specifically defined by the Department of Fish and Game of the State of California, ranging from 60 to 100 feet deep, consisting of about 5,000 tons of viaduct demolition debris and a scrapped kelp harvester vessel together with the possible Naval Ocean Systems Oceanographic Platform. Overall size is estimated to be 0.11 nautical miles wide by 0.65 nautical miles long, with plastic buoys of a type nonhazardous to small craft.

2. That the City Clerk of said City is hereby authorized and directed to forward a copy of this resolution to the Department of Fish and Game, Marine Resources Operations, California State Fisheries Laboratory, Terminal Island, California.
