RESOLUTION NUMBER R-266864 ADOPTED ON OCTOBER 27, 1986

WHEREAS, Council Policy 100-4 states that the San Diego Convention and Visitors Bureau (CONVIS) shall submit to a performance audit every two to five years; and

WHEREAS, the policy also indicates that funds to pay for such an audit shall come from a source other than CONVIS's annual funding allocation of transient occupancy tax and in fiscal year 1985, \$25,000 was encumbered for the purpose of conducting a CONVIS performance audit; and

WHEREAS, in fiscal year 1986, a request for proposals was issued twice with no response; and

WHEREAS, based upon that experience and conversations with audit firms, it is estimated that \$75,000 would be necessary to fund the CONVIS audit; and

WHEREAS, the \$25,000 encumbered in fiscal year 1985 is still available and the additional \$50,000 needed is available in the fiscal year 1986 fund balance for transient occupancy tax revenues; and

WHEREAS, City Manager Report No. 86-428, issued September 11, 1986, recommends that the request for proposals be reissued and that the audit commence in fiscal year 1987; and

WHEREAS, the Public Services and Safety Committee, last considered and approved the matter on October 1, 1986, updating the request for proposals in the process, and directed that the

item be forwarded to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the scope of the request for proposals for a management and organization study of CONVIS be and the same is hereby approved to include therein performance standard measurements for equal opportunity for staffing, contractors, and subcontractors.
- 2. That the City Manager be and he is hereby fully authorized to distribute and advertise the request for proposals, a copy of which is on file in the office of the City Clerk as Document No. RR-266864, for the purposes stated hereinabove.
- 3. That the City Manager be and he is hereby fully authorized and empowered, for and on behalf of said City, to execute an agreement with the lowest responsible bidder after evaluation of submitted request for proposals documents.
- 4. That the Auditor and Comptroller be and he is hereby fully authorized to transfer the amount of \$50,000 within Transient Occupancy Tax Fund 10223 from fiscal year 1986 fund balance to Organization 506, Object Account 4222, Job Order No. 91506, to augment the \$25,000 previously authorized by Resolution No. R-262836, dated April 8, 1985, said total amount to be used solely and exclusively for the purpose of conducting said CONVIS performance audit.
- 5. That the Auditor and Comptroller be and he is hereby authorized to expend a sum not to exceed \$75,000 for the purpose

of conducting said CONVIS performance audit, under the terms and conditions of the agreement executed in respect thereto and upon satisfactory completion of said terms.
