GENERAL DESCRIPTION

The San Diego Facilities and Equipment Leasing Corporation was created as a non-profit organization in 1986 to assume ownership of certain facilities which the City of San Diego has caused to be financed and constructed. These facilities currently consist of the Police Headquarters Building, the Heavy Vehicle Maintenance Facility, the Southeastern Area Station, and the Western Area Station. Additional facilities may be added in the future. Corporation ownership of these facilities may assist the City in mitigating potential indirect property tax liabilities related to these facilities. Non-Personnel Expense reflects property tax payments (\$375,000), attorney fees (\$50,000), audit fees (\$1,500), and State license taxes (\$450).
