Mary Taylor	Attorneys	\$329.40	Ms. Taylor is an Intermediate Typist with the Criminal Division. She suggested adding the time that the case is going to court on case request forms used by private attorneys. Actual savings of \$1,098.00 in time has been realized. This is her full award.
John Juanico	Park & Recreation	\$320.00	Mr. Juanico is the Recreation Center Director of Eastern Division. He suggested identifying base anchor positions on ball fields with plastic feathers. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Ronald Lamour	Police	\$320.00	Mr. Lamour is a Detective in the Northern Investigations Unit. He suggested taking color Polaroids of felony suspects prior to booking arrests. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Daniel Ignosci	Fire	\$200.00	Mr. Ignosci is a Captain. He suggested reporting hazardous material with pre-fire plans. Although savings are difficult to identify, this is considered to be a significant operational improvement.
