Richard Leap	Fire	\$180.00	Mr. Leap is a Captain. He suggested while wearing a SCBA, transmit messages via a portable radio by placing it next to the throat. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Anthony Dickens	General Services	\$100.00	Mr. Dickens is a Senior Equipment Repair Supervisor in the Equipment Division. He suggested the modification of the exhaust system on IHC trash trucks when transmissions are exchanged. The award amount is based on Ordinance #8758, Section 22.1017 procedure at the time of submittal.
Thelma Shuker	Attorneys	\$ 25.00	Ms. Shuker was a Programmed Typewriter Operator at the time of this suggestion. She suggested providing extra typewriters to the PTO's for typing variations and subpoenas. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Robert Peters	Attorneys	\$ 25.00	Mr. Peters is a Senior Engineering Aide with the Engineering & Development Department. He suggested notifying the attorney's office of the State regulations pertaining to speed survey specifications. Although savings are difficult to identify, this is considered to be a significant operational improvement.
