WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where a street has been superseded by relocation; and

WHEREAS, the vacation of a portion of El Camino Real in conjunction with North City West Unit No. 7 (T.M. 85-0793) is required to facilitate development; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That a portion of El Camino Real in conjunction with North City West Unit #7 (T.M. 85-0793), as more particularly shown on Exhibit "A" on file in the office of the City Clerk as Document No. RR-266882, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That the resolution shall not become effective unless and until the final subdivision map for North City West Unit #7 (T.M.

85-0793) has been approved by Council action and the realigned portion of El Camino Real is open to traffic. In the event that the realignment is not open to traffic and a final subdivision map for North City West Unit #7 is not approved by three years after adoption of this resolution, then this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, with Exhibit "A," attested by him under seal, to be recorded in the office of the County Recorder.




