

RESOLUTION NUMBER R- 266893

ADOPTED ON OCT 28 1986

WHEREAS, in January 1985, The City of San Diego and the County of San Diego initiated a joint program for the preparation of a SPHERE OF INFLUENCE STUDY for the City's northern boundary; and

WHEREAS, City and County staff have completed a service analysis for the SPHERE OF INFLUENCE STUDY area and identified alternative Sphere of Influence boundaries; and

WHEREAS, to date, the policy committee of the SPHERE OF INFLUENCE STUDY has been unable to meet to review and make a recommendation on a Sphere of Influence boundary causing delays in the SPHERE OF INFLUENCE STUDY program; and

WHEREAS, the Executive Director of the Local Agency Formation Commission (LAFCO) has requested the City to expedite the submittal of a recommended Sphere of Influence to LAFCO and has scheduled November 3, 1986, for the consideration of the Sphere of Influence for the City's northern boundary; and

WHEREAS, the Council of The City of San Diego has considered the alternative Sphere of Influence boundaries; and

WHEREAS, the City's recommended Sphere of Influence boundary includes portions out of the unincorporated County as provided for in Planning Department Report No. 86-603; and

WHEREAS, the City's recommended Sphere of Influence boundary provides a natural geographic boundary for the City; and

WHEREAS, the urbanization of the unincorporated County land included in the City's recommended Sphere of Influence will interact with and impact surrounding City communities; and

WHEREAS, the City, as a single agency, would best provide services and determine priorities for service distribution to the affected area as it urbanizes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council approves a Sphere of Influence for the City's northern boundary that includes portions of the unincorporated County as identified in Planning Report No. 86-603, on file in the office of the City Clerk as Document No. RR- 266893, and strongly encourages the Local Agency Formation Commission to adopt said Sphere of Influence as reflected in Planning Report No. 86-603.
