WHEREAS, the San Diego City Council has been videotaping its Monday afternoon Council meetings for delayed cablecasting Monday evenings on Cox and Southwestern cable systems since February 1985; and

WHEREAS, the Council meeting cablecasts are accessible to more than 300,000 cable-subscribing households on Monday evenings and videotapes are made available for viewing at other times to individuals, businesses and schools to better inform San Diegans of their City government's actions and to encourage greater public knowledge of and participation in local government; and


