WHEREAS, Earl was voted Most Valuable Defensive Player of the All Star Team in 1962; and

WHEREAS, Earl Faison was the American Football League Defensive Player of the Year in 1963; and

WHEREAS, Earl became Captain of the Chargers in 1964; and

WHEREAS, Earl was named to the All-AFL Team in 1960, 1961, 1963, 1964, and 1965; and

WHEREAS, Earl Faison was named San Diego County Football Coach of the Year in 1974; and

WHEREAS, Earl Faison has given his time and energies to the Kidney Foundation, Special Olympics, the Ronald McDonald House, NFL Charity Golf, the San Diego Padres Community Advisory Council, and United Way; and

WHEREAS, Earl Faison has been a teacher at Muirlands Junior High School since 1968, founded the Athletic Institute for Motivation to teach women the game of football and has coached Youth Basketball; and

WHEREAS, Earl Faison, known affectionately by his fans as "Big Earl" is to be inducted into the Chargers Hall of Fame November 2, 1986; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby acknowledge and congratulate Earl Faison on his sterling career of achievement, exemplified by his recent induction into the San Diego Chargers Hall of Fame.
