- 2. That the City Council hereby sets aside City owned land in a portion of Section 33, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described on the

drawing attached hereto, for drain and sewer purposes in exchange for the easement being abandoned.

3. That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
