
RESOLUTION NUMBER R- 266955

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of July 11, 1986, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 266955, granting to said City an easement for public street purposes in a portion of Section 24, Township 14 South, Range 4 West, and a portion of Section 19, Township 14 South, Range 3 West, San Bernardino Meridian, and in Lots 33 and 34 of the Employment Center Development Unit No. 2C, Map No. 11460, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named EL CAMINO REAL and HIGH BLUFF DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
