WHEREAS, Council Policy 300-6, entitled "Employer-Employee Relations," authorizes the City's employee organizations to use the payroll deduction system for membership dues and insurance premiums; and

WHEREAS, the San Diego Police Officers Association has requested that the employee organizations be allowed to use the payroll deductions system for employees who wish to pay for the Police Department's 1986 Commemorative Album by having the cost deducted from their paychecks for eight to twelve pay periods; and


WHEREAS, the Management Team recommends that Council Policy 300-6 be waived for this limited purpose; and

WHEREAS, the City Auditor indicates that this waiver will not result in a significant increase in workload; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the payroll deduction restrictions contained in Section VI.B. of Council Policy 300-6, entitled "Employer-Employee Relations" are hereby waived, for eight to twelve pay periods, to permit payroll deduction of employees of the San Diego Police Department who wish to pay for the Police Department's 1986 Commemorative Album.
