WHEREAS, the recommended Third Amended Agreement is in the best interest of this City and the entire San Diego region; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized to execute the

Third Amended Unified San Diego County Emergency Services

Agreement, a copy of which is on file in the Office of City Clerk
as Document No. RR-266.967.

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$80,000 from Department 110, Organization 318, Account 4222, Job Order 111406 is hereby authorized solely and exclusively for the above purposes and further authorizing the City Auditor and Comptroller to credit the appropriate reserves with unexpended funds.
