RESOLUTION NUMBER R-266975 ADOPTED ON NOVEMBER 3, 1986

WHEREAS, at the PF&R Committee meeting of October 8, 1986, the San Diego Unified School District requested a waiver of fees for the use of Plaza Hall and several meeting rooms on November 7 and 8, 1986, for the purpose of using those facilities for a program of conferences and seminars entitled "Succeeding in a Global Society;" and

WHEREAS, Council Policy 700-43 provides that CPAC facilities will not be made available to any individual or organization without payment of the appropriate fees and charges; and

WHEREAS, that policy further provides that if the City

Council grants a special waiver of fees, a reimbursement to CPAC

in the full amount of the waived fees shall be made from a

funding source designated by the Council; and

WHEREAS, CPAC estimates the fees and charges for the requested waiver totals \$6,974 and the direct, out-of-pocket expenses the Center would incur amount to \$2,633; and

WHEREAS, the PF&R Committee voted 5-0 to forward the matter to the full Council with no recommendation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the provisions of Council Policy 700-43 in respect to payment of fees for use of CPAC facilities, be and the same are hereby waived, to the fiscal extent set forth below.

BE IT FURTHER RESOLVED, that the fees applicable to the use of CPAC facilities by the San Diego Unified School District, for a conference on November 7 and 8, 1986, be and the same are hereby waived in the amount of \$4,341, with the amount of \$2,633 remaining to be paid by the San Diego Unified School District.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer said sum of \$4,341 from the General Fund 100, Unallocated Reserve (605) to the Allocated Reserve (901), for the sole and exclusive purpose of reimbursing the Convention and Performing Arts Center, for use of CPAC facilities by the San Diego Unified School District on November 7 and 8, 1986.
