RESOLUTION NUMBER R- 266984

ADOPTED ON NOV 3 1986

WHEREAS, in July of 1986, the City Council unanimously approved the formation of a United States Olympic Site Ad Hoc Task Force to act as the official liaison between the U.S. Olympic Committee and The City of San Diego; and

WHEREAS, the purpose of said Task Force is to meet the anticipated competition for establishment of a warm weather Olympic training center; and

WHEREAS, a local Olympic Training Site would provide a myriad of advantages of San Diego such as (1) an opportunity for local athletes to train and possibly fulfill their dream of participating in future Olympics; (2) another tourist attraction for visitors to our city; and (3) an addition to the already high prestige of The City of San Diego; and

WHEREAS, in order to best pursue this objective, it is necessary and desirable to employ an experienced individual to coordinate all the efforts necessary for such task; and


WHEREAS, hiring a consultant to spearhead our efforts to be selected as an Olympic training site is recommended by the U.S. Olympic Training Center Site Ad Hoc Task Force and it recommends that \$25,000 should be set aside for this purpose to be matched by contributions from the private sector; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and

empowered, for and on behalf of said City, to seek and employ a consultant for the purpose of coordinating all efforts necessary in order to successfully promote The City of San Diego in the selection process as the location for the United States Olympic warm weather training center.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$25,000 from the Unallocated Reserve (605) to the Allocated Reserve (901), for the sole and exclusive purpose of funding the above contractual service.
