RESOLUTION APPROVING THE GREATER GOLDEN HILL
PRECISE PLAN AMENDMENT.

WHEREAS, on June 26, 1986, and August 28, 1986, the Planning Commission of The City of San Diego held public hearings for the purpose of considering an amendment to the GREATER GOLDEN HILL PRECISE PLAN; and

WHEREAS, the purpose of the amendment is to precisely define the boundary between the GREATER GOLDEN HILL PRECISE PLAN area and the Greater North Park Community Plan area; and

WHEREAS, the precise boundary, as delineated on EXHIBIT A attached hereto is justified insofar as the boundary delineation is primarily for purposes of clarification; and

WHEREAS, this Council has reviewed the amendment to the GREATER GOLDEN HILL PRECISE PLAN and approves and recommends adoption of said amendment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves and adopts the amendment to the GREATER GOLDEN HILL PRECISE PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 266994 .

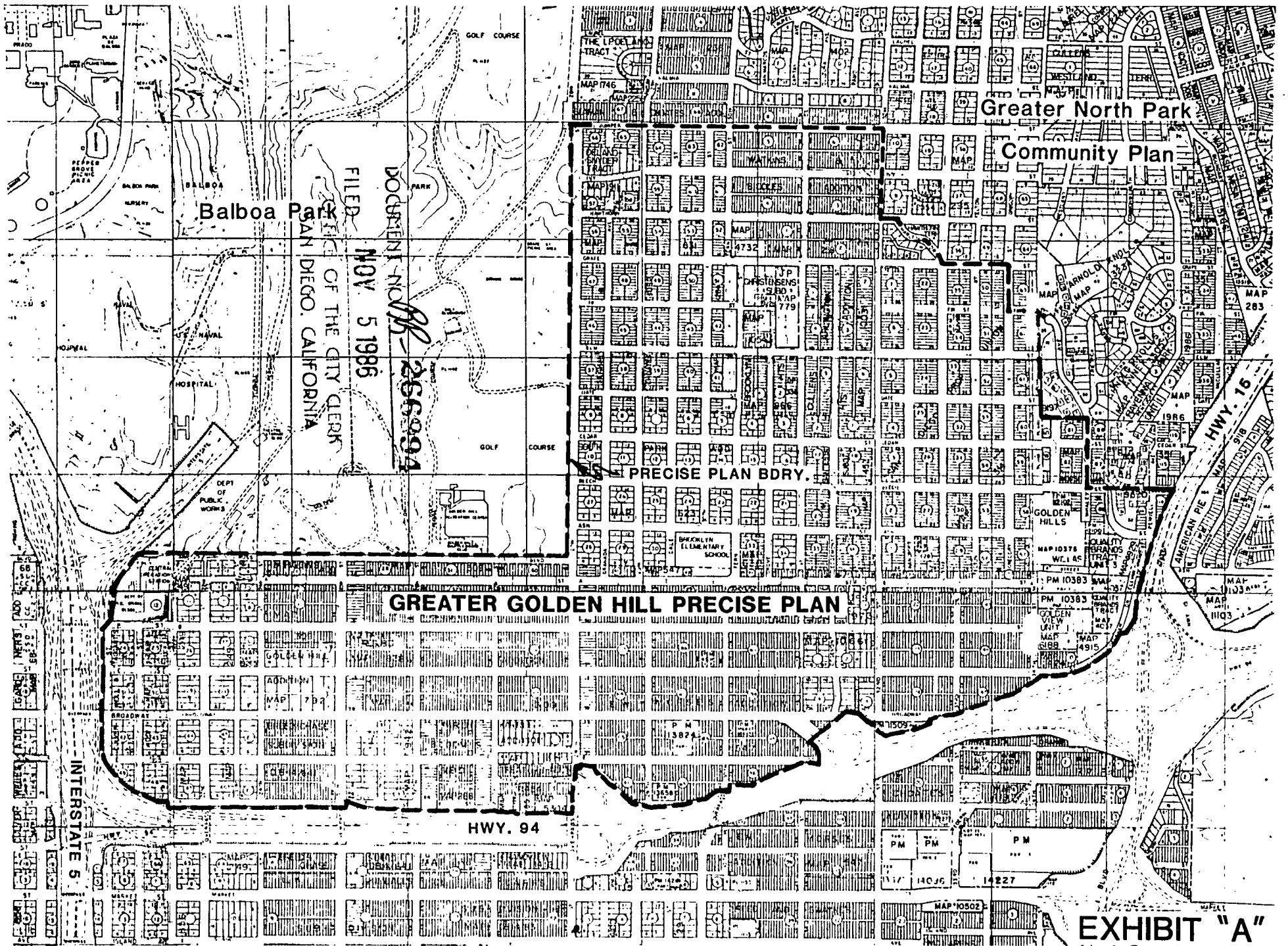
