RESOLUTION NUMBER R- 267002

ADOPTED ON NOV 8 1986

WHEREAS, appointments to boards and commissions are governed procedurally by Council Policy No. 000-13; and

WHEREAS, the City Council adopted Ordinance No. O-16721 (New Series) on October 6, 1986 which amended section 98.0301 of the San Diego Municipal Code relating to the membership composition of the San Diego Housing Commission; and

WHEREAS, said amendment, which shall be in full force and effect on November 4, 1986, provides that Councilmembers may be appointed as members of said Commission in those membership positions other than the two (2) low-income tenant positions; and

WHEREAS, it is now intended to appoint five (5) Councilmembers to said Commission, effective January 3, 1987; and

WHEREAS, it will be necessary to waive the provisions of Council Policy 000-13 in respect to advance notification by the Mayor to Councilmembers for the purpose of soliciting input; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the advance notification procedure contained in Council Policy 000-13 be and the same is hereby waived.

BE IT FURTHER RESOLVED, that the following appointments by the Mayor of The City of San Diego to serve as members of the San

Diego Housing Commission, to be effective January 3, 1987, be and
the same are hereby confirmed:


