


RESOLUTION No. R- 267018 (R-87-785)

Adopted on NOV 10 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE CONSTRUCTION OF IMPROVEMENTS TO LA JOLLA VILLAGE DRIVE/MIRAMAR ROAD FROM INTERSTATE 5 TO EASTGATE MALL, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on NOV 10 1986 and bearing official Document No. W.O. 118659 be, and the same are hereby approved.
- 2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for THE CONSTRUCTION OF IMPROVEMENTS TO LA JOLLA VILLAGE DRIVE/MIRAMAR ROAD FROM INTERSTATE 5 TO EASTGATE MALL.
- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$400,000 from Gas Tax Fund 30219, Program No. 322211 to CIP No. 52-281 LA JOLLA VILLAGE DRIVE/MIRAMAR ROAD.
- 5. That the expenditure, not to exceed \$2,200,000 (\$1,800,000 from North Universtiy City FBA Fund 79001 and \$400,000 from Gas Tax Fund 30219) from CIP No. 52-281 LA JOLLA VILLAGE DRIVE/MIRAMAR ROAD, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
