RESOLUTION NUMBER R- 267033

ADOPTED ON NOV 10 1986

WHEREAS, the City Council has committed itself to end hunger in San Diego; and

WHEREAS, Church World Service, in concert with ministerial associations and interfaith groups throughout San Diego County, is sponsoring "Walks for the Hungry" on the weekend before Thanksgiving in eight locations throughout the county, including Chula Vista, Escondido, La Jolla, Oceanside, Ramona, San Carlos, Southeast San Diego and Uptown San Diego; and

WHEREAS, proceeds from these walks will be used by Church World Service for hunger relief projects throughout the world and for eleven designated local community agencies involved in feeding the hungry; and

WHEREAS, the local beneficiaries of the eight walks being held in the region are Meals on Wheels in South Bay, Project Hand in Chula Vista, the North County Interfaith Crisis Center in Escondido, the Ecumenical Service Center in Oceanside, the Ramona Food and Clothes Closet, the Professional Community Food Services Program in El Cajon, the Heartland Human Relations Association in La Mesa, St. Didacus' Kitchen and the Community Food Bank in Southeast San Diego, the Uptown Interfaith Service Center and the San Diego Hunger Coalition; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does

hereby proclaim November 22-23, 1986, as "Walk for the Hungry Weekend."

BE IT FURTHER RESOLVED, that Church World Service, the Navajo Interfaith Association, the North County Interfaith Council, the North Park Clergy Association, the Oceanside/Carlsbad Ministerial Association, the Ramona Ministerial Association, the South Bay Ministerial Association, the Southeast Interdenominational Ministerial Alliance, the Sweetwater Ecumenical Council, the Uptown Clergy Association, and the Bishops' School are hereby commended for their tireless efforts to end hungry and to reduce the suffering of millions of our fellow human beings.
