

- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for INSTALLATION OF CITY-OWNED STREET LIGHTS AT VARIOUS LOCATIONS CITY WIDE 1986.
- 4. That the expenditure of \$150,000 from Capital Outlay Fund 30245, CIP No. 52-293 ANNUAL ALLOCATION INSTALLATION OF CITY-OWNED STREET LIGHTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in the Capital Outlay Fund 30245, CIP No. 52-293 ANNUAL ALLOCATION INSTALLATION OF CITY-OWNED STREET LIGHTS.
