RESOLUTION OF INTENTION TO DETACH FROM THE SAN DIEGO OPEN SPACE PARK FACILITIES DISTRICT NO. 1 CERTAIN TERRITORY IN THE COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, "OTAY VALLEY/PALM AVENUE REORGANIZATION."

WHEREAS, in connection with the establishment of San Diego Open Space Park Facilities District No. 1, pursuant to the provisions of Section 61.2000 et seq. of the San Diego Municipal Code, provisions were made for the boundaries of said District to be and remain the same as the boundaries of The City of San Diego; and

WHEREAS, in the past, pursuant to Section 61.2070 of the San Diego Municipal Code, properties have been annexed to the San Diego Open Space Park Facilities District No. 1 in connection with annexation of properties into The City of San Diego; and

WHEREAS, the City of San Diego has recently approved the detaching of certain properties from the City of San Diego and it is now appropriate to similarly detach said properties from the San Diego Open Space Park Facilities District No. 1; and

WHEREAS, the documents relating to the formation of the San Diego Open Space Park Facilities District No. 1 provide for the detachment of property from a park facilities district; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that its intention is hereby expressed to conduct a hearing which will

be held in the Council Chambers on the 12th Floor of the City Administration Building, 202 "C" Street, San Diego, California, on December 16, 1986, at 10:00 A.M., at which time the Council will consider whether or not to detach the "Otay Valley/Palm Avenue Reorganization," as more particularly described in Exhibit A attached hereto, from the Open Space Park Facilities District No. 1.

BE IT FURTHER RESOLVED, that the owners of said property or any portion thereof may appear at the hearing and be heard, orally or by writing, signed by them, and may present evidence in support of or in opposition to the proposed detachment.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to post a copy of this resolution on the bulletin board of the City Administration Building and to cause a copy of this resolution to be published in the Daily Transcript once a week for two weeks prior to the hearing, the posting and first publication to be on or before the tenth day prior to the day of the hearing.

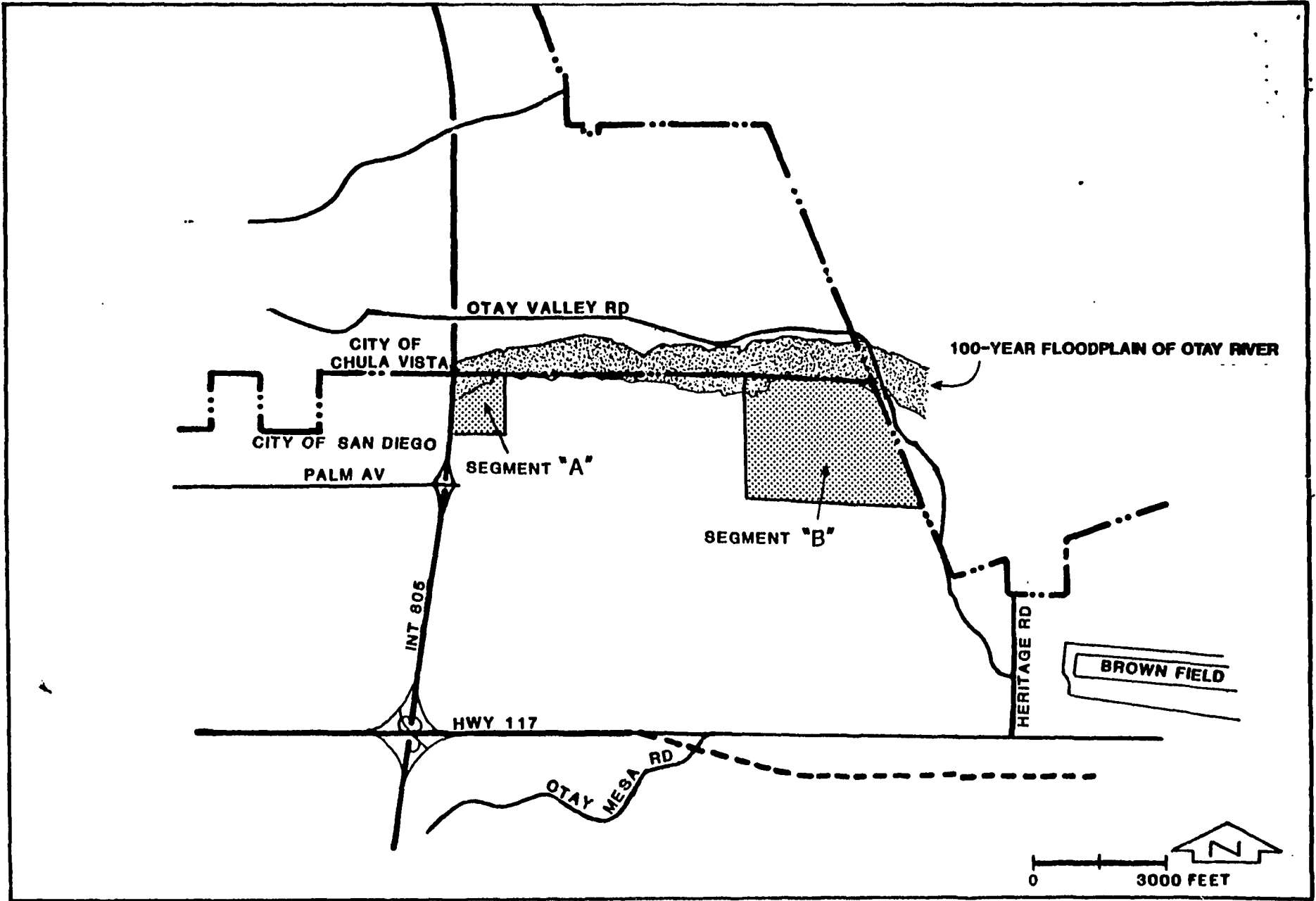
