RESOLUTION NUMBER R-267059

ADOPTED ON NOVEMBER 18, 1986

WHEREAS, this past year in this county, the immigration and naturalization service alone made fifty-nine narcotic seizures valued at some \$75 million and one load of cocaine seized at the border this past year weighed 1,284 pounds; and

WHEREAS, we live in a community where accessibility to drugs is easy and getting easier; and


WHEREAS, the effects of this easy availability, and consequently, relatively cheap prices, are statistically observable in our young people; and

WHEREAS, it is necessary and desirable to provide straightforward, accurate and clear information on the perils of drug use and, in addition, teach our youngsters how to resist peer pressures and how to say no to their friends; and

WHEREAS, such information program essentially requires a declaration of war on drugs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, does hereby declare Tuesday, November 18, 1986, to be the "Mayor's D-Day on the War on Drugs."
