William Stanley Nolan Howard	Utilities	\$5,000.00	Mr. Stanley was a Senior Water Utility Supervisor and Mr. Howard was an Equipment Technician II with the Systems Division at the time of this suggestion. They suggested installing automatic grease feeders to the bearings on pumps at Station #64. The actual savings is \$34,446.30. This is their full award.
Robert Daneri	General Services	\$ 500.00	Mr. Daneri is an Equipment Repair Supervisor with the Equipment Division. He suggested installing a hot stick PTO and frame mounted hydraulic pump on the 9600 Master trucks. Although savings are difficult to identify, this was considered to be a significant operational improvement.
