Wilma Divinagracia	Auditors	\$200.00	Ms. Divinagracia is an Account Clerk. She suggested notifying vendors of credit memo application by attaching notices to checks. Although savings are difficult to identify, this was considered to be a significant operational improvement.
William Trevino	Fire	\$160.00	Mr. Trevino is a Fire Engineer. He suggested stopping hazardous chemicals and liquids from spreading past their point of origin. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Martha Schanno	Park & Recreation	\$100.00	Ms. Schanno was an Intermediate Stenographer with the Park Development and Open Space Division. She suggested providing a wallet size card containing procedures for on-the-job injuries. Although savings are difficult to identify, this was considered to be a significant operational improvement.
